WAYS TO COMPLETE THE REALTOR® ETHICS TRAINING CYCLE 6 – January 1, 2019 – December 31, 2020

The Metro Centre Association of REALTORS® (MCAR) requires members to complete the 2.5 hour REALTOR® Ethics Training every 2-year cycle – Jan. 1, 2019 – Dec. 31, 2020 for Cycle 6 - as required by the National Association of REALTORS®. Some of the classes are also approved for continuing education (CE) credit as required by the New Jersey Real Estate Commission (NJREC)*.

*Continuing Education (CE) is a requirement by the New Jersey Real Estate Commission (REC) for real estate licensees in New Jersey. Licensees are reminded that to be eligible to renew their license for the 2017-19 license term they will need to have acquired a total of 12 credit-hours of continuing education, including at least six in Core topics, of which at least two must be in Ethics.
